The properties located to the east of the application site are set at a higher level than the application site and the existing properties on Nethertown Road.

# Proposal

In March 2024, a variation of conditions application (ref: 4/24/2022/0B1) was approved to vary conditions 2 to amend the floor and elevation plans for plot 2 only of planning approval 4/23/2086/0B1. This current application seeks to vary condition 2 relating to the submitted plans for this development to allow for a change in house type for plot 2.

Cumberland Council are continuing the preparation and progression to adoption of the ELP.

The Local Plan Examination Hearing Sessions were completed in March 2023.

The appointed Planning Inspector issued their post hearing letter in June 2023, which identified the next steps for the examination.



The appointed Planning Inspector has now considered all representations and the discussions that took place during the Local Plan Examination Hearing Sessions in 2023 and has identified a number of amendments or 'modifications' that are required in order to ensure the ELP is sound i.e. positively prepared, justified, effective and consistent with national planning policy.

A six week public consultation seeking views on the proposed modifications to the ELP commenced on Wednesday 14th February 2024 and closed on the 28<sup>th</sup> March 2024. The Planning Inspectors Report is awaited.

# Assessment

Under Section 73 of the Town and Country Planning Act 1990, an application can be made to vary or remove a condition associated with a permission. The effect of an application under Section 73 is the issue of a new permission sitting alongside the original permission, which remains intact and unamended. The NPPG outlines that to assist with clarity it states that decision notices should also repeat the relevant conditions from the original permission unless they have already been discharged. As a Section 73 application cannot be used to vary the time limit for implementation this condition must remain unchanged from the original permission.

In terms of the conditions attached to the previous decision notice (ref: 4/23/2086/0B1), condition 1 will be left blank as works on site have already commenced. Conditions 6, 10, 11, 12 and 15 will be repeated to ensure that works are carried out as per the approved details.

Condition 7 will be updated to reflect that this condition has been discharged in part for plot 3 only. An additional condition will be added to ensure that Plot 3 is carried out in accordance with the materials approved under the discharge of conditions application. Conditions 3, 4, 5, 8, 9, 10, 13, and 14 will also be amended to reflect the updated plans as submitted within this current S73 application.

Condition 2 relates to the approved plans for this application. This application seeks to vary
