## DISCUSSION



We visually inspected the large, mature Lime tree

From the Cumberland Council website, the site falls within the Whitehaven Town Centre Conservation Area. And a Tree Preservation Order (TPO) does not protect the tree.

We consider the work detailed in the application reasonable to prevent the tree causing damage to vehicles.

Our TEMPO assessment (page 2) shows the tree does not merit a TPO.

For your information, a copy of the Council's Arboriculturalists Report is enclosed.

## Your Right of Appeal

If you disagree with our decision you can appeal to The Planning Inspectorate, Environment and Transport Team, 3/A Eagle Wing, Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN within 28 days from the date you received this decision.
