RE: T1, T2, T3 & T4. ASH TREES WITH ADVANCED ASH DIEBACK. TREES REGULARLY SHEDDING BRANCHES INTO NEIGHBOURING PROPERTY TO THE REAR, PROPOSE FELLING THE TREES AND NOT REPLACING AS REPLACEMENT TREES ARE ALREADY GROWING ADJACENT TO THE ASH TREES. AT: WOODSIDE, RHEDA PARK, FRIZINGTON

I refer to your application of the 1<sup>st</sup> April 2025 under the above Tree Preservation Order for consent to carry out the following work:-

# **DESCRIPTION OF PROPOSAL:**

APPLICATION TREE NO.	SPECIES	PROPOSED WORKS
1, 2, 3, & 4	4 X Ash	T1, T2, T3, & T4. Ash tree with advanced Ash Dieback. Trees regularly shedding branches into neighbouring property to the rear, propose felling the trees and not replacing as replacement trees are already growing adjacent to the Ash trees.

### **Discussion**

The four ash trees are in the mature age class and show signs of Ash Dieback disease (<a href="https://www.forestresearch.gov.uk/tools-and-resources/fthr/pest-and-disease-resources/ash-dieback-hymenoscyphus-fraxineus/">https://www.forestresearch.gov.uk/tools-and-resources/fthr/pest-and-disease-resources/ash-dieback-hymenoscyphus-fraxineus/</a>).

We expect these four trees will last for less than 10 years.

The trees overhang the neighbouring property and branch, or trunk failure could cause damage or harm.

The trees are protected under the Tree Preservation Order TPO 13 (1952).

A TEMPO assessment has been undertaken and this shows a TPO is indefensible due to the poor health and reduced life expectancy of these trees.

#### Decision:

I would confirm that there are no objections to the proposed works as details within the application.

## **Your Right of Appeal**
