#### **DISCUSSION**

The trees are in the mature age category and show signs of moderate to normal vitality.

The site falls within the St Bees Conservation Area although a Tree Preservation Order (TPO) does not protect these trees.

The work detailed in the application is considered to be reasonable to prevent the trees becoming a nuisance.

Our TEMPO assessment shows a TPO is defensible, but given the work the applicant is proposing, it is considered to be unwarranted at this time.

#### **Decision:**

I would confirm that there are no objections to the proposed works as detailed within the application.
