RE: PRUNING OF FOUR SYCAMORE TREES SITUATED WITHIN A CONSERVATION

**AREA** 

AT: 3 SEACROFT DRIVE, ST BEES

I refer to your application of the 9<sup>th</sup> May 2025 under the above Tree Preservation Order for consent to carry out the following work:-

### **DESCRIPTION OF PROPOSAL**

TREE ID NO.	SPECIES	PROPOSED WORKS
T1 – T4	4x Sycamore trees.	Pruning of four sycamore trees situated within a Conservation Area.
REASON		

#### KEASUN

'T1, T2 & T3 are in close proximity resulting in overlapping branches. Requesting permission to lift and thin out the crown of all 3 trees to allow more light into the garden, provide clearance of buildings and safety over shared driveway. Also removal of deadwood on T1 which led to branch falling in recent storms.

T4 – Crown lifting and thinning to allow more light into garden and reduce overlapping branches of canopy and overhanging neighbour's driveway.'

#### DISCUSSION

The trees are in the mature age category and show signs of moderate to normal vitality.

The site falls within the St Bees Conservation Area although the trees are not protected by a Tree Preservation Order (TPO).

The work detailed in the application is considered to be reasonable to prevent the trees becoming a nuisance.

A TEMPO assessment has been undertaken which shows a TPO is defensible, but given the works proposed this is considered to be unwarranted at this time.

## **Decision**

I would confirm that there are no objections to the proposed works as detailed within the application which are considered to be reasonable to prevent the tree causing a nuisance.

## **Your Right of Appeal**

If you disagree with our decision you can appeal to The Planning Inspectorate, Environment and Transport Team, 3/A Eagle Wing, Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN within 28 days from the date you received this decision.

# **Compensation**
