VARIOUS PRUNING WORKS TO TREES PROTECTED BY A TREE PRESERVATION ORDER

LLEWEN, RHEDA PARK, FRIZINGTON

I refer to your application of the 30th June 2025 under the above Tree Preservation Order for consent to carry out the following work:-

DESCRIPTION OF PROPOSAL

APPLICATION TREE NO.	SPECIES	PROPOSED WORKS
T1 – T6		Various pruning works to trees protected by a Tree Preservation Order.

'T1, Elm. T2, Ash. T3 Elm. T4 Elm. T5 Sycamore. Prune branches back to boundary fence to a max height of 5m complying with BS3998 max cut diameter 5cm.

T6, Ash. prune bottom branch to inside boundary fence with diameter exceeding 100mm that has no suitable pruning point.

The purpose of the work is to maintain the trees suitable to their situation in relation to 5 & 6 Elm Way Frizington CA26 3TL.'

Decision

I would confirm that there are no objections to the proposed works as detailed within the application subject to the following condition:

1. Carry out all pruning work in accordance with BS3998:2010 Tree work – Recommendations.

Reason

In accordance with Section 198 of the 1990 Town and Country Planning Act and in the interest of good arboricultural practice.

Your Right of Appeal
