T1	1x Ash	Pruning of branches and 30% crown reduction of ash tree (t1) situated within a Conservation Area.	'T1, Ash. The Ash tree located in the rear garden of 23 Main Street, St Bees has Ash Dieback with the crown spread across the properties of 8 and 10 The Crofts. The proposal is to prune the lateral branches back within the boundary of 23 Main Street and reduce the height by 30%. It will not be possible to adhere to BS3998 but we will retain as much live crown as possible and remove the lvy to allow for regeneration from dormant buds as the owner does not want the tree removed at this time.'

The Ash tree is in the mature age class and shows signs of Ash Dieback Disease (AshDieback-GuidanceNote-web.pdf)

The site is within the St Bees Conservation Area. We consider the work detailed in the application reasonable to prevent a tree failure causing a damage or harm. Our TEMPO assessment shows a TPO is indefensible.

Your Right of Appeal

If you disagree with our decision you can appeal to The Planning Inspectorate, Environment and Transport Team, 3/A Eagle Wing, Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN within 28 days from the date you received this decision.

Compensation
