

Sycamore (T1) - fell due to excessive shading of garden and development of concerning phototrophic lean in close proximity to house. Due to the specimens poor form with excessive lean and in-balanced crown, pruning works cannot be used to rectify tree shape and reduce shading without causing the specimen detrimental harm. The spacing between trees in the woodland area is too small so T1's removal will prevent damage to these trees from congestion.
