The facility will be required for the long term and has been designed to ensure that it is fit-for-purpose for the future.

The layout of the development will respond to the topography of the site, with the buildings being set into the rising slope. The development will comprise of a main building which is two/three storeys high owing to the site topography. The main building will be flanked by single storey ancillary buildings (a garage and kennels) and an upper level car park to provide for operational response vehicles.
