Eg. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

T1 Ash: T1 is a semi-mature Ash located to the side of the driveway directly behind a garage wall. This Ash tree has previously been hard topped and reformed a multi stemmed included union. The crown overhangs the garage roof with some limbs only a foot above, phone lines twine through the crown. Removal of this tree is recommended due to its poor form and position over value targets.

7. Identification Of Tree(s) And Description Of Works continued ...

T2 & T3 Sycamore: T2 & T3 are semi-mature Sycamores seemingly self seeded in a raised area between the garage and carriageway wall. The trees are growing around a telegraph pole and through numerous lines, they will soon begin damaging these. It is recommended these trees are removed before they outgrow the locality.
