ALL THREE STEMS HAVE LARGE WOUNDS CAUSED BY BLEEDING CANKER. THE TREE IS INFECTED WITH THE PARASITIC FUNGI KRETZSCHMARIA DEUSTA WHICH CAUSES SOFT ROT IN THE LOWER STEM AND ROOTS AND CAN LEAD TO SUDDEN FRACTURE ON OTHERWISE HEALTHY LOOKING TREES. RONEY FUNGUS IS ALSO PRESENT WHICH CAUSES WHITE ROT IN THE LOWER

STEM AND ROOTS AND CAN LEAD TO WIND THROW. THE TREE PRE DATES BOTH CAR PARKS SO ROOT DAMAGE WOULD BE INEVITABLE. DECAY IS PRESENT IN THE ROOTS & BUTTRESS. THIS APPLICATION IS AIMING TO FULLY MITIGATE THE RISK TO LIFE & LIABILITIES, THE CAUSE OF WHICH IS POOR RESISTANCE OF THE SPECIES TO DECAY AND THE NATURE & CLOSE PROXIMITY OF THE TARGETS I.E. LIFE AND PROPERTY, THEREFORE THE WORK PROPOSED IS TO SECTIONALLY DISMANTLE THE TREE.
