THESE ARE SYCAMORE TREES AND REQUIRE TOPPING AND TRIMMING FOR THEIR OWN HEALTH AND THE FACT THAT THEY ARE TAKING A GREAT DEAL OF LIGHT FROM THE APPLICANTS PROPERTY.

THE APPLICANT IS ALSO CONCERNED THAT IN THE LONGER TERM THE TREES WILL PRESENT A DANGER TO THEIR PROPERTY BY FALLING AND/OR BLOCKING THE BECK. (THEY ARE NOT A DANGER AT THE MOMENT.) THE WORK WILL BE TO REDUCE THE TREES BY  $\frac{1}{3}$  (33%) OF THEIR CURRENT HEIGHT UNDERTAKEN BY A PROFESSIONAL TREE SURGEON AT THE APPLICANTS EXPENSE. THE WORK WILL REQUIRE ACCESS TO THE ROYAL OAK CAR PARK. THE APPLICANT HAS SECURED AGREEMENT IN PRINCIPLE TO DO THIS AT A CONVENIENT TIME TO BE AGREED
