Sycamore, close to the garage (see attached photo). During November 2023 we contacted Copeland for advice about a tree that we thought was dead and would like to remove. The council's Open Space Manager who is a qualified arborist visited the site and advised us that the tree wasn't dead but could be removed due to it being in a poor condition. He advised us to follow the tree works planning application process. He provided some further comments, including:

- Normal procedure to follow for removal should be followed in this case.
- Quite important that replacement tree should be seawind resistant. Possible placed at least 2 m away from garage and current tree.
- Signs of honey fungus in the grass area are concerning so would possible insist of root grinding operation when tree is being felled.
- Suitable replacement tree Acer campestre(field maple) or Betula pendula (birch)

We propose to follow the Open Space Manager's advice.
