The application site is located within Leconfield Industrial Estate, which is located centrally within Cleator Moor approximately 600m to the north-west of the town centre. The Estate is accessed via the B5295 'Leconfield Street' which is at its southern boundary.

The application site extends to approximately 1.27Ha and is located in the north east part of the Estate. The site was formerly occupied by two industrial structures which were demolished in c.2015, leaving only the concrete slabs in situ. More recently the site has been part utilised by BOC Gases Ltd. as a compound for the storage and distribution of bottled gas products and part utilised by a scrap merchant.
