Discussed renewing planning permission for the existing Dog Grooming studio located in the garage at 2 Solway Rise. Previous site information was provided for the previous planning application in 2021. Guidance and support provided about Bio-diversity net gain and how this site is exempt and provided the information around why it is exempt, with additional support surrounding the statement provided. Also discussed my queries around possible extension in time frame of review. Previous planning application was time limited to 3 years in order to safeguard the community. Advised to discuss with development control, Cumberland Council. Nick Hayhurst also provided information regarding previous planning application, identifying that the use of the dog grooming studio is not permitted beyond the 3 years and proposed I provide a statement with relevant information to explain why it would be appropriate for continued use and request for an extension in a statement.
