This plot was purchased and is owned by The University (not leased). We already have a 20ft storage container sited within an unused area of our private car park. This area of the car park is at the rear of the building, not visible to the public, and the car park area is only for use by our own staff and visitors. The storage container is used to store research/scientific equipment and consumables that we cannot store internally due to space constraints. We have had this storage container on site for 3 years and wish to apply to extend this for a minimum of another 3 years.
