Dear Mr Geering
I refer to your recent enquiry relating to the above tree at Pinethwaite, Lingnmell, Seascale.
Following a visit and inspection by Julian Smith who is the Council's Interim Parks and Open Spaces Manager I can confirm the following:-
One tree has come down and can be removed The tree adjacent to the fallen tree has been impacted by the fallen tree and the root plate is less stable than previously was the case. This tree is more vulnerable in high winds. Consequently Julian Smith has recommended the following works:-
Pollard the tree to approx. 12ft in height. This would remove the risk while allowing the tree to recover and re-establish. Remove two large limbs over-hanging the access road to reduce the weight on that side of the tree and to re-balance it. These limbs in question are clearly visible on the attached photo.
You should submit an application to undertake these works and also cover the removal of the tree which has fallen down.
I have attached a copy of the relevant application form in order that you can submit your application to the Local Planning Authority. There is no fee required in this case.

Spruce

One tree has come down and needs be removed

Poplar, adjacent to Lane

Pollard the tree to approx. 12ft in height. This would remove the risk to users of the Lane and adjacent properties while allowing the tree to recover and re-establish.

Remove two large limbs over-hanging the access road to reduce the weight on that side of the tree and to re-balance it.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
