There is a mature acer pseudoplatanus (sycamore) located in the back garden of Mr and Mrs Metcalfs property (54°26'46.1"N 3°31'10.6"W). As their property is within approx 10-8 meters of the tree in question, they have raised concerns that due to the recent stormy weather we have had, branches have been falling and generally the canopy spread has grown larger since the last reduction. As a result they have asked us to apply for tree work to be done, similar to that carried out previously; we estimate that to be about a 20-30% reduction as it currently stands.

## Identification of Tree(s) and Description of Works

We have suggested a reduction of about 20-30%, taking limbs back to pruning cuts that were agreed and accepted by yourselves previously.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
