T1. Ash, tree has Ash Dieback and a heavy lean over the neighbouring property. Propose dismantling to leave a standing stem at approximately 4 metres for habitat. Would not suggest replanting as the tree is positioned in woodland growing very close to other trees.

T2. Ash, Tree has Ash dieback. Propose pruning 3 lateral branches that encroach over neighbouring property back to the main stem as there are no suitable pruning points inside the owners boundary.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
