The project is part of a national NHS England pilot to provide early intervention and support in the heart of local communities to transform access to mental health and wellbeing support. Local residents have chosen the name 'Hope Haven' and the hub will bring together a range of services and staff under one roof. The service will be individually tailored around the person's needs and priorities.
