T1, Yew. Tree is growing against the gate stoop of croft lodge causing cracking to the wall and branches on road side are causing obstruction to highway. Propose to fell the tree without replacement as no space for another tree as many other trees exist close by.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
