Application to remove birch tree located at the border between 1 Fleatham Gardens and 2 Fleatham Croft on the grounds that it constitutes a nuisance to the residents of 2 Fleatham Croft.

Context.

Recent inspection of the tree by Bruce Hatton (Arborist) has identified upper crown dieback with minimal deadwood, likely due to root damage, soil contamination around the roots or a noxious substance contacting the vascular system. Bruce Hatton has recommended removal of the minor deadwood alongside flushing of the soil around the roots to remove any possible contaminants, with a view to reassessing at the end of the summer. Report attached, reference PP-14141006/001

In recent weeks, the occupants at 2 Fleatham Croft have contacted us to express serious concerns regarding the proximity of the tree to their property (photos included in this application, reference PP-14141006/003 & PP-14141006/004) and their anxieties around the potential of the tree/limbs to fail and cause damage to their property. We have observed high winds recently and our neighbours have reported that some of the limbs of the tree have reached as close as approx. 1 metre from their 1st floor living room window.

The birch was previously located very close to a sycamore and hence the birch has grown further toward 2 Fleatham Croft to afford itself the light that it needed, prior to the relevant approval being sought and the sycamore being removed. It can be seen in the attached photos that the tree is visibly leaning over the boundary towards 2 Fleatham Croft and would be closer to their property than would be expected if the birch had not been dwarfed by the now felled sycamore tree.

Although Bruce Hatton has not cited any immediate or serious concerns regarding health of the tree, there is still potential for the aforementioned works to be unsuccessful and the health of the birch may continue to deteriorate.

We would therefore like to remove the birch to alleviate the concerns of our neighbours and to negate future works that may eventually include removal, if the recommended work the arborist has cited didn't lead to recovery of the tree.
