I wish to build a field shelter measuring 20 foot wide (6 metres) by 10 feet deep (3.6 metres) with a height of 2360mm at the eaves and 2900mm at the apex. The stable will be made of wood with a Caroline or equivalent roof . The floor will have hard standing which will be paving slabs on top of gravel or equivalent , making it a removal floor if the need was to arise. There will be no electricity or water connections.

There will be drain pipes to collect water into containers so that it can be used for the animals to drink.

It will have two openings on the front and will be split into 2 separate compartments inside.

It will be a natural wood colour on the exterior.

Stable to be erected 8 metres back from the fence line approx 1 metre in front of the existing land drains.
