T1, Black Poplar. Low hanging branches from the tree are striking the church roof on windy days. Propose reduction pruning of low branches to provide 2m clearance of church building.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
