Plot 04 of the 8 new dwellings has been purchased by Mrs. Butler and there are some alterations to the planning approved design that require a separate consent.

1. Ridge height to be increased by 324mm to appear in line with Plot 05.
2. Rear dormers increased to be built off the external walls to allow for new sliding door installation and glazed guarding, the dormer roofs have all increased in size however still subservient to the main roof.
3. The first floor internal layout has been amended to reflect how the client would like to use the space. A new en-suite position to the main Bedroom 01 space requires the installation of a small velux rooflight - shown on the front elevation & 3d Sketches provided.
4. The first floor en-suite window to side elevation 02 has been removed due to the en-suite position change in item 03.
