## Description of Proposed Works

Please describe the proposed works

Planning permission requirements for a proposed boundary fence at my property.

The fence in question will run for approximately 50 metres along the boundary of our property, which borders the public road known as U4022 (Hensingham to Frizington road). This is a new-build property, and we are currently in the process of establishing suitable boundary treatments.

The proposed fence would be positioned approximately 1 metre back from the road at road level. However, our land sits around 1 foot higher than the road, which significantly reduces the effectiveness of a standard 1 metre-high fence in providing privacy.

The request of a 2 meter fence also increases the level of privacy and security for the family on such a busy road.

We have already taken steps to soften the boundary by constructing a crest and planting laurel hedging. Unfortunately, due to the exposed nature of the site and high wind conditions, the hedging is taking longer than expected to establish. The installation of a fence would not only improve privacy but also act as a windbreak to support the long-term growth of the planting.

Proposed work:

- Installation of Concrete posts securely anchored into the ground
- Fixing of wooden fence to a height of 2 metres
- Finishing treatments to the wood to ensure durability and weather resistance
