To excavate banking and build a block wall adjacent to the side and front elevation of our house. This to extend the current driveway to create more parking space. Block wall to the side elevation is to be 6 concrete hollow block high with rebar inserts (total approx. height 1.5m) with slate copings on top (total length of the 6 block high wall of is approx. 15.5m. The wall will be stepped down from 6 hollow block high down to 2 block high in line with the gradient of the banking. the front elevation of the wall will be 2 block high.

The banking that is removed will be replaced with Type1 hardcore, then membraned and topped to finish with 40mm slate chippings to provide hard standing for car parking.
