For the existing driveway to be widened, the removal of a gate and partial removal of fence along with the relocation of a lamppost 4.1m West are required.

A verbal agreement has been reached with the neighbour the movement of the lamppost effects.

The extension of an existing drop kerb and relocation of existing transition kerb is required.

An addition of permeable block pavers (2.4m x 6.3m) to partially replace the existing concrete drive, provides level access to the van.
