Application to remove all branches of sycamore stump (labelled as SS1 in sketch PP-15132173-1) and lateral removal of branches of small sycamore (labelled as S1 in sketch Pp-15132173-1) up to the boundary wall between Fleatham Farm and Fleatham Gardens (land owned by the owner of Fleatham House).

Both sycamore tree branches and sycamore stump regrowth branches are now encroaching on our property over the boundary wall into Fleatham Farm as shown in photographs PP-15132173-2, 3 4 5 and 6.

Although we are unaware of any health issues with either of the aforementioned trees, we are still concerned of the potential of limbs to fall onto our property, causing damage to our car.

We only wish to perform the minimum works required as stated above to reduce the burden of the trees overhanging our property, whilst still maintaining the ecology and aesthetics of the local conservation area. We have sought permission from the landowner who is supportive of the application and we agree to take responsibility for the branches should the owner not wish to keep them.

Identification of Tree(s) and Description of Works

Removal of regrowth branches from sycamore stump (as labelled as SS1 in sketch) and lateral reduction of sycamore branches (labelled as S1 in sketch) up to the boundary wall between our property (Fleatham Farm) and Fleatham House.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
