I have had a look and in my opinion, a modest front extension is likely to be acceptable. As you have said, there are other examples of similar development on Bransty Road and it is unlikely to have a material effect on the street scene. I would comment though, that any development should consider the habitable room on the front of the neighbouring dwellings, so that they do not experience any loss of amenity.
