Beech (Number 4 on location plan) - Crown lift away from house and path side to balance
Alder (Number 6 on location plan) - Sever Ivy on left tree, crown lift both and reduce right one back from lighting, footpath, building
Beech (Number 7 on location plan) - Sever Ivy at base and allow to dieback
Cherry (Number 8 on location plan) - Sever Ivy at base and allow to dieback
Cherry (Number 15 on location plan) - Remove Elder beneath cherry as no development potential
