T1 Maple, fell because leaning stem is overhanging lodge. Replant with 3 x Field Maple in the 6-8cm light standard size

T2 Oak, crown lift by removing 2 x low branches over lodge roof

T3 Sycamore, fell because stem is damaging decking structure of lodge. Replant with 3 x Sessile Oak in the 6-8cm light standard size

G1 5x Wester Red Cedar, overhanging roofs of lodges, crown lift to give additional 3m clear stem

T4 Horse Chestnut, crown lift by removing 2 x low branches over lodge roof
