The proposed work is the addition of a new slate vent in the roof of the rear offshoot to allow for improved ventilation of the existing main bathroom with a mechanical extract fan as part of the refurbishment of this room.

For the other aspects of the bathroom refurbishment no features of historic interest could be affected and listed building consent is not being sought. These other aspects involve replacement of modern bathroom fittings and a modern plasterboard ceiling, no structural alterations are required and there are no additional services or waste outlets required to be provided to the room.
