Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

I contacted the council to clarify if a tree, on my property, was part of a TPO or not - being fairly confident it was not as the TPO I had from ~1950 didn't appear to have it registered on it and the trees size is far too small - compared to all the surrounding trees which are (clearly) part of the TPO. The council sent through a copy of their updated protected tree mapping system which seemed to indicate the small tree (or one very close to it - the map was slightly off) is part of the TPO - despite not seeming to agree with the original ~1950 TPO. The council (parks manager) couldn't conclude if the tree was part of the TPO and have requested that I complete this application to "allow the tree to be assessed by a qualified arborist".

The tree is located at what3words location: ///wonderful.oxidation.lodge (the small tree between the 'path' and very large ash tree).

As per council recommendation, I am requesting that an assessment is carried out to determine if the tree is part of the TPO or not. If it is concluded that it is not part of the TPO, I am planning to fully remove the tree.

I believe the tree in question is between T94 & T95 on "Cumberland County Council Tree Preservation (No.23) (Rheda Estate, Frizington) Order 1950" - ie not part of the TPO.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
