The treeworks application relates to a single castanea sativa identified as tree 4 in the tree schedule and indicated on the woodland plan, highlighted in red.	
Whilst the tree appears healthy at its base it has for a number of years increasing lost its upper foliage. The tree is clearly dead/dying and	
leafless branches are routinely dropping to the ground.  The upper branches do approach High House Road and the tree presents a safety hazard in its present condition.	
The proposal is to fell the tree.	
In its leafless form the tree does not contribute to the overall tree feature that the remainder the woodland provides.	
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
