Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree (T3) is a mature Sycamore, one of two remaining trees in the small garden of 1 Fleatham Gardens.

The crown has significant dieback, with small chlorotic foliage, leaf drop and an absence of foliage at the top of the crown.

There are rhizomorphs at the stem base, close to a small wound and attached to the tree's cambium, indicating that it has been colonised by

This pathogen degrades tree roots before moving into the lower stem. The presence of Armillaria means the tree's eventual death is inevitable.

It is likely that the Sycamore's roots have already been degraded and it is likely to fail in high winds.

This application is to remove the tree by felling before it fails.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
