## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Beech Tree in front garden of Townhead Cottage.

It has a fungal Meripilus disease as stated by both Emanuel Flecken, Open Spaces Manager at Copeland Council on the 07-10-22 and a United Utilities Tree Surgeon last year. This disease destroys the tree roots and it will eventually topple.

In addition the tree has swelled at the trunk base and is causing damage to a stone wall, in a conservation area, that will eventually collapse into the road.

Also the tree canopy overhangs utility supply cables and falling branches have the potential to both hit road users and cut service supply to village homes.

Additionally the tree branches overhang Hunter How's roof causing potential damage from branches in high wind and may also impact Tregatha if the tree were to topple.

Finally if the tree were to topple the water and sewage supply to the village may be impacted as it runs beneath.

This application is to fell said tree.

We intend to plant a replacement tree, if feasible given the soil is infected with Meripilus; and will take advice from both Emanuel Flecken and an arborist as to the appropriate species.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
