Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1, Cherry. Honey fungus present in abundance on roots visible on lawn indicating advanced infection, Propose 1m crown reduction to reduce leverage and maintain the tree at a smaller size to extend its life.
- T2, Cherry Plum. Infected with Cushion Bracket which causes soft rot then white rot. Tree is close to and leaning towards the church. Propose to fell tree before it can fail potentially causing damage to the medieval building.
- T3, Beech. Heavily leaning due to the effects of wind. Propose pruning to maintain 2.5m clearance for visitors and grass cutting, also reshape to reduce lean.
- T4, Willow. Previously coppiced due to failure now growing with heavy lean from decaying stool. Propose re coppice or heavy reduction.
- T5,T6 & T7, Poplar previously topped with some broken branches. Propose clean prune and 1.5m crown reduction to lower chance of regrowth breaking in high winds.
- T8, Whitebeam. Propose to fell due to excessive decay and dead wood.
- T9, Birch. Propose 2m crown reduction to reduce risk of stem failure due to large wound probably caused by removal of co dominant stem at approximately 1.5m which is now decaying into main stem.
- T10, Poplar. Previously crudely pollarded adjacent to road. Propose 2 to 3 metre crown reduction to reduce chance of further branch failure over main road.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
