2 metre reduction of cherry tree required to remove encroachment on building. The tree is to be reduced using a pole saw and all waste removed from site. The team will secure the pathway to ensure no public interference. Team to identify the Christmas lights within the tree and prune around them without disturbance. Lights to be turned off and unplugged prior to work commencement.
