Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1, Red Cedar, co dominant stem situated adjacent to highway. One stem badly girdled with what looks like a ratchet strap and decayed down to ground level leaving vulnerable to failure. Propose fell the tree.
- T2, Lime, Crown lift to give 2 metre clearance to garage roofs. All pruning cuts to comply to BS3998:2010
- T3, Sycamore, Fell due to extensive crown dieback and Kretzschmaria Deusta present on butt.
- T4, Sycamore, Fell due to extensive crown dieback and Kretzschmaria Deusta present on butt.
- T5, Sycamore, Fell due to considerable decay and hollow in butt and Honey fungus present.
- T6, Sycamore, Extensive crown dieback and decay on stem. Tree appears to be retrenching below decay. Propose reducing height by 50% to mitigate against failure of large compromised stem wood.
- T7, Sycamore, Large wound close to ground with extensive decay and infected with Polyporus Squamosus. Propose reducing height by 30% to reduce risk of stem failure and prune lower branches clear of summer house.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
