Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

This treeworks application relates to the felling and removal of two diseased trees within the Highcroft woodland.

The first, is the acer pseudoplatanus marked as tree 8 on the tree schedule and woodland plan. The tree is an aged double with the one limb have being removed some time ago ie greater than ten years. As can be seen from photograph 1, the bracket fungus polyporous squamosas has developed at the base of the tree. Having a the same condition causing an acer pseudoplatanus in the same woodland to fall and block the roadway in 2013 I consulted a senior arborist who confirmed both the disease type and the recommendation to fell on safety grounds. The second, is a fraxinus excelsoir marked as 18 on the tree schedule and woodland plan. The tree has been suffering from ash dieback for a

number of years with limbs increasing being stripped of leaves, dying and falling to the ground. Again with the risk of the tree falling across the roadway high the proposal is fell the tree.

Due to the collection of surrounding woodland, tree 18 removal will not adversely impact the outlook of the woodland, and whilst tree 8 may do so, the owner has attempted to mitigate by the planting of young betula pendulas in the spring 2018.

The house is likely to change owners in the short term but the current owners felt that the safety risk to the public is too high to ignore, and they feel they have a duty of care to the new owners, their neighbours immediately adjacent to tree 8, the road users and the general public.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
