Whitehaven Marina have a short term agreement with the land owner for the use of the application land. WML seek a temporary consent to use the land until the land owner secures consent for their preffered development scheme.

We seek to extend the currently consented operation of boat storage onto the application land. We would be re-instating a previousely lawful use of the land which complements the neighbouring activity of boat storage. Use of the land will also increase the number of FTE and PTE at the marina, for the duration of the use of land. The extended area will also generate an increase in boating activity to Whitehaven town, as we will continue to progress oour marketing initiatives to attract new busines and people to the town of Whitehaven.
