Provision of an additional secure storage container to the rear of the telephone exchange building. Container is to house materials and equipment in support of the telecoms infrastructure, such as excavations tools, ducting, fibre cable and man hole covers. This is set on existing ground to the rear of the building obscured from view. The Government has set a target to connect a minimum of 85% of premises to gigabit-capable coverage by 2025. The solution of setting up small storage depots is both sustainable and effective in meeting the needs of the roll out. Containers are preferred as a high number of thefts have been reported from BT sites as they are generally unmanned for periods of the day.
