Details of the pre-application advice received

APPLICATION REFERENCE: PAA/24/0001

I refer to your request for pre-application advice which was received on 8th January 2024.

Is Planning Permission Required?

I have now had an opportunity to review the site on the Councils GIS mapping system and the information submitted as part of the enquiry. I would advise that planning permission would be required for the replacement of the windows and door, but not for the replacement of the soffits, bargeboards and fascias.

The building is situated adjacent to the Whitehaven Conservation Area.

"I note that the building is outside the conservation area and is not historic although is within the setting of the conservation area, by virtue of being immediately beside it and that the building is in a rather unconvincing faux-historic style.

I do not think on that basis I could insist on reinstatement of timber windows and that plastic would therefore be acceptable subject to the right detailing, however I would request that the larger openings (where there are currently false two-over-two sliding sashes) are instated with actual sliding sash windows. I believe this would achieve a betterment despite the change of material. The smaller openings would appear to suit a side-hinged casement similar in style to the existing. I see there's a louvred plant room opening at first floor level (presumably to allow plant to be craned into place or taken off a forklift or platform lift) and presume these will need to be retained in timber.

I also note that the grade II* listed Catherine Mill is c. 70m away across an uninterrupted car park. The Health Centre is therefore within its setting. Given the distance, however, the quality of the setting in this area and the contribution the Health Centre makes to it, I would likely view the impact on the setting as negligible.

Conclusion

It is likely that the proposed development will be considered to be acceptable when assessed against local planning policies. Full details of the design and proposed materials would be required in order to make a full assessment.
