DISCUSSION

The two Ash trees (T1 & T2) are in the early-mature age class and suffering from Ash Dieback Disease (<u>https://www.forestresearch.gov.uk/tools-and-resources/fthr/pest-and-disease-resources/ash-dieback-hymenoscyphus-fraxineus/</u>). We expect the trees will last for less than 5 years.

The Leylandii hedge (T3) is an outgrown hedge in the early-mature age class, and contributes little to the landscape character of the area.

The trees overhang garden areas and one of the symptoms of Ash Dieback Disease is the wood becomes brittle, which can lead to branch or trunk failures.

From the Copeland website, a Tree Preservation Order – TPO 20 (1984) – protects these trees. The website does not say if the trees are protected as part of a Group, Area or Woodland Order.

Our TEMPO assessment below shows a TPO is indefensible due to the health and life expectancy of these trees.

RECOMMENDATIONS

We recommend informing the applicant they can carry out the work detailed in the application subject to the following conditions:

1. The felled hedge must be replaced during the first planting season following the work. Plant a mixed native species hedgerow in a similar location. Alternatively, another size, species, location, or period should be agreed in writing by the Local Planning Authority. If the replacement trees die, become diseased, or are damaged within 5 years of the planting date, they must be replaced in the next available planting season by another of a similar size and species.

Reason: To ensure the continuity of amenity in accordance with 'Policy DM28 – Protection of Trees' of the Copeland Local Plan 2013-2028.
