Good morning,

Please see the following response from the applicant in relation to the question raised in your response below:

In response to the Parish Council points:

a) There is already screening in the form of hedges that are adjacent to the erected and future building. These hedges have been allowed to grow in height in the 3 years we have lived here and we intend to let them continue to grow and this will increase screening.

b) There are 16 sheep and 36 hens on site.

c) Sheep numbers do and will have small fluctuations throughout the year due to lambing and subsequent sales of stock but there is a core flock of 16. We will not be increasing the number of hens in the future.

d) The animal waste will be managed via regular transfer to a local farmers biodigester, as is the case now. A small amount is composted in existing compost bins on site and used for our garden/vegetable beds.

I would be grateful if you could review and provide any additional comments within 14 days of this email.
