Thank you for consulting us on the above application, received 7 November 2024.

We have reviewed the application details in so far as it relates to our remit, and we are not satisfied with the failure to acknowledge flood risk.

Section 12 of the application form 'Assessment of Flood Risk' has marked 'no' in relation reference to Flood Map for Planning and Flood Zones 2 and 3. The Project Outline document (prepared by West Cumbria Rivers Trust) includes no reference or acknowledgment to flooding and policy requirements have not been addressed.

It has not therefore been demonstrated that the development would be safe without exacerbating flood risk elsewhere.

Environment Agency position

In the absence of a flood risk assessment (FRA), we have no option but to object to this application and recommend that planning permission is refused.

Reason

The application site includes areas within Flood Zone 3, which is land defined by the planning practice guidance as having a high probability of flooding. The National Planning Policy Framework (paragraph 167, footnote 55) states that an FRA must be submitted when development is proposed in such locations. An FRA is vital to making informed planning decisions.

In its absence, the flood risks posed by the development are unknown. This is sufficient reason for refusing planning permission.

Overcoming our objection

To overcome our objection, the applicant should submit an FRA which demonstrates that the development is safe without increasing risk elsewhere. Where possible, it should reduce flood risk overall.

If this cannot be achieved, we are likely to maintain our objection. Please re-consult us on any revised FRA submitted and we'll respond within 21 days of receiving it. Environmental permit - advice to applicant

The River Ehen is a designated statutory main river.

The Environmental Permitting (England and Wales) Regulations 2016 require a permit to be obtained for any activities which will take place:

- on or within 8 metres of a main river (16 metres if tidal)
- on or within 8 metres of a flood defence structure or culverted main river (16 metres if tidal)
- on or within 16 metres of a sea defence
- involving quarrying or excavation within 16 metres of any main river, flood defence (including a remote defence) or culvert
- in the floodplain of a main river if the activity could affect flood flow or storage and potential impacts are not controlled by a planning permission
