Good Afternoon

Thank you for the opportunity to comment on the above planning application. This response from the Joint Emergency Management and Resilience Team relates to emergency planning arrangements in the unlikely event of an incident occurring at Sellafield Ltd. The Sellafield site is currently covered by the provision of the Radiation (Emergency Preparedness and Public Information) Regulations 2019.

The location of the land is situated outside of an area referred to as the Detailed Emergency Planning Zone (DEPZ), therefore no direct liaison with the applicant is required in relation to warning and informing information.

However, the location of the land does sit within a distance of 10km from the Sellafield site, an additional area known as the Outer Consultation Zone (OCZ) and, as such, it is highly likely that those involved in the redevelopment of the land may pass through the Sellafield Detailed Emergency Planning Zone. Therefore, it is strongly advised to signpost the applicant to the Cumberland Council Emergency Planning webpage where general information about the Sellafield site can be found plus warning and informing guidance on actions to take if there is an Off-Site Nuclear Emergency.
