REASON				
'The trees in question are a mixed hedge of Elder, Hawthorn, Blackthorn and Field Maple				

'The trees in question are a mixed hedge of Elder, Hawthorn, Blackthorn and Field Maple which have been neglected for some time and some of which have grown greater than 75mm at breast height. I propose to reduce the hedge to approximately 1.5 metres so that it can be managed as a hedge in future by the church volunteers.'

DISCUSSION

The trees are in the early-mature to mature age category and show signs of normal vitality. The trees are currently unmanaged and appear to be a grown-out hedgerow.

From the Cumberland Council website, the site falls within the St Bees Conservation Area. A Tree Preservation Order (TPO) does not protect the trees.

We consider the reasons for the work detailed in the application to be acceptable and given the age of the trees, we expect the trees will continue to grow once the work has been carried out.

Our TEMPO assessment (page 2) shows these trees do not merit a TPO.

RECOMMENDATIONS

Inform the applicant they can carry out the work in the notification or wait for the sixweek determination period to lapse.
