DESCRIPTION OF PROPOSAL

1x Sycamore	20-30% reduction of a mature Acer pseudoplatanus (Sycamore) tree protected by a Tree Preservation Order.			
REASON				

There is a mature acer pseudoplatanus (sycamore) located in the back garden of Mr and Mrs Metcalfs property (54°26'46.1"N 3°31'10.6"W). As their property is within approx 10-8 meters of the tree in question, they have raised concerns that due to the recent stormy weather we have had, branches have been falling and generally the canopy spread has grown larger since the last reduction. As a result they have asked us to apply for tree work to be done, similar to that carried out previously; we estimate that to be about a 20-30%

reduction as it currently stands.

We have suggested a reduction of about 20-30%, taking limbs back to pruning cuts that were agreed and accepted by yourselves previously.

DISCUSSION

The Sycamore tree is in the mature age class and show signs of normal health.

From the Cumberland Council website, Tree Preservation Order (TPO) No.64:1998 protects this tree. The website does not say if the tree is protected as part of a Group, Area or Woodland Order.

Our TEMPO assessment (page 3) shows a TPO is defensible for this tree.

Given the health, age and size of the tree, we expect the proposed work will not significantly impact the local or wider amenity of the area. We consider this work will not have a detrimental impact on the wider landscape; therefore, we consider the proposed work is acceptable.

RECOMMENDATIONS

We recommend informing the applicant they can carry out the work in the application subject to the following condition.

We recommend attaching the following conditions:

1. Carry out all pruning work in accordance with BS3998:2010 Tree work – Recommendations section 7.7 'Crown reduction and reshaping'.
